Artificial intelligence (AI) is developing at a rapid pace. From generative language models like ChatGPT to advances in medical screening technology, policymakers and the developers of the technology alike believe that it could deliver fundamental change across almost every area of our lives. Such change is not without risk. Debate is ongoing on how best to regulate these innovative technologies and differences of approach have already emerged internationally as countries across the world examine how best to adapt.

This report shows benzodiazepines remain the most commonly identified group of psychoactive substances submitted, with a total of 18 identified. WEDINOS analysis again highlights concerns of substance substitution within the UK drug market. Over the past year, Bromazolam was the most commonly identified benzodiazepine, and most often purchased with the belief that it was Diazepam. Because Bromazolam is more potent than Diazepam, this creates enhanced risk of harm and overdose as individual consumers are not aware of dose, time of onset of effects, duration of effects or contraindications with other substances

This compendium was developed as background for the Seventh Ministerial Conference for Environment and Health, "Accelerating action for healthier people, a thriving planet, a sustainable future" (Budapest, Hungary, 5–7 July, 2023). Its purpose is to catalyse and support national and subnational activities for environment and health. It recognizes that identifying and delivering an appropriate blend of environment and health policies and programmes for the 21st century presents a significant challenge for national and subnational authorities and agencies, but that it can be facilitated by drawing selectively on a suite of resources. The compendium succinctly describes these resources – a mix of concepts/frameworks, approaches, and tools – some of which are already widely used in environment and health, while others have yet to be developed and/or effectively deployed.

Despite robust structures and protocols to deliver the environment and health agenda in countries across Europe and implicit understanding that an infectious pandemic was possible, coronavirus disease (COVID-19), when it hit, was a massive shock. Few operating in the environment and health discipline, at any level, could have anticipated the full range of challenges to the environment, health and equity as the deadly virus circulated and society adopted unprecedented measures to manage and control it. A vast volume of academic and grey literature continues to accrue, with analysis and reflection on what occurred, what can be learnt and the implications for future preparedness. The declaration by WHO on 5 May 2023 that COVID-19 is no longer a public health emergency of international concern and the sobering reality that nearly 2 250 000 people in the WHO European Region died from the disease must engender a period of meaningful reflection and also sustained action. The aim of this policy brief is to support the necessary reflection and action by distilling the impacts of the pandemic on the many domains of environment and health and summarizing the evidence that its roots lie in disregard for events at the interface of human, animal and environmental health.

As the NHS marks its 75th anniversary, the founding principles of the health service – that care would be free at point of delivery, available to all and funded from tax – are largely the same. But how care is delivered and how the system is organised have changed significantly since 1948. This anniversary presents a moment to reflect on how far the NHS has come and to look to the future. Recent years have seen the NHS face unparalleled challenges. The COVID-19 pandemic followed a decade of austerity, driving waiting lists to new heights and exacerbating longstanding workforce shortages. Amid record low public satisfaction and unprecedented industrial action, the health service is in crisis. So what does the public think about the NHS now and the challenges that lie ahead?

This report summarises the information from the surveillance systems which are used to monitor coronavirus (COVID-19), influenza, and other seasonal respiratory viruses in England. References to COVID-19 represent the disease name and SARS-CoV-2 represent the virus name. The report is based on data from week 28 (between 10 July and 16 July 2023) and for some indicators daily data up to 18 July 2023.

The report stated: 'Fundamental reform of the dental contract is essential and must be urgently implemented, not only to address the crisis of access in the short-term, but to ensure a more sustainable, equitable and prevention-focussed system for the future. A new recovery plan for NHS dental services has also been promised by ministers, according to the report, but this is yet to be published. This follows the release of the NHS Long Term Workforce Plan, which will increase training places for dentists by 40% by 2031/32. Recommendations from the committee include urgent changes to the dental contract, the commission of a dental workforce survey, and incentives to attract and retain dentists within the NHS. These could be the reintroduction of NHS commitment payments, incentive payments for audit and peer review and the introduction of late career retention payments.

Both the government and independent climate change committee, agree on the adaption efforts to mitigate related risks. This summer the government is due to publish tha latest edition of its five yearly national adaptopn programme. This will detail how it plans to go about addressing climate risks and comes 15 years after the Climate Change Act 2008 became law.

The major conditions strategy is a national framework being developed by the Department of Health and Social Care (DHSC) and the Office for Health Improvement and Disparities (OHID). It will focus on six major groups of conditions: cancers; cardiovascular diseases, including stroke and diabetes; chronic respiratory diseases; dementia; mental ill health; and musculoskeletal disorders. It will cover the whole care pathway from prevention to treatment, including the role of innovation to improve outcomes. Take forward the Levelling Up health mission to narrow the gap in healthy life expectancy by 2030, and increase healthy life expectancy by 2035. Alleviate pressure on the health system and reduce ill-health related labour market inactivity.

In 2022, WHO published the *Consolidated guidelines on HIV, viral hepatitis and STI prevention, diagnosis, treatment and care for key populations*. These guidelines outline a public health response to HIV, viral hepatitis and sexually transmitted infections (STIs) for 5 key populations (men who have sex with men, sex workers, people in prisons and other closed settings, people who inject drugs and trans and gender diverse people). In this policy brief, we give an update on those parts of the guidelines which are relevant for people in prisons and other closed settings.

This report provides an epidemiological overview of key sexual health infections and interventions, including sexually transmitted infections (STIs), emergency and long-acting reversible contraception (LARC) provision and termination of pregnancy in Wales up to the end of 2022. The report is aimed at policy makers, health service clinicians and planners, commissioners, criminal justice and third sector agencies and academia.

Taking action to protect children from the harmful impact of food marketing. A child rights-based approach. World Health Organization. WHO; 2023.

This joint UNICEF and WHO publication aims to guide governments and partners through the steps to introduce policies to protect children from the harmful impact of food marketing. Structured into three parts, the first part describes the impact of food marketing on children and identifies the main developments and challenges in the marketing landscape observed in the past decade. Part 2 outlines why a child rights-based approach can and should be used by governments to restrict food marketing. Part 3 identifies how governments can take action to restrict food marketing and is organized by the main stages in a policy cycle: policy preparation, policy development, implementation (including enforcement and monitoring for compliance), and monitoring and evaluation for policy impact. This publication expands on previous guidance and outlines steps to strengthen the government's position against legal challenges, it outlines oppositional tactics and common arguments used against policies and provides counterarguments based on a child rights-based approach and the available scientific evidence.
